

Thank you for allowing us to be a part of this special time in your life. Here's an overview of today's Prenatal Intake appointment.

Our number to reach us 24 hours a day / 7 days a week is 617-479-6636.

1. During the appointment

a. Full History, weight, and blood pressure were taken

2. Routine Laboratory Tests - being drawn today

- a. Rubella checking for immunity to German measles
- b. Varicella- checking for immunity to the Chickenpox virus
- c. Hepatitis B
- d. Hepatitis C
- e.HIV
- f. RPR-Syphilis
- g. Hemoglobin A1C- general status of blood sugar for the past 3 months
- h. Urinalysis and Urine Culture to check for an infection
- i. Complete Blood Count (CBC) checks for anemia among other issues
- j. Blood type and RH
- k. Urine Drug Test
- I. Any additional blood work will be added and discussed as needed

3. Genetic Screening (Chromosomal)

- a. Nuchal Translucency (NT) ultrasound was booked
- i. To be done between 12.5 weeks and 13.6 weeks
- ii. You need to have a full bladder for this appointment
 - 1. 12 oz of fluid 1 hour prior to the appointment and do not urinate
- b. Options for genetic testing blood work- will be done at the NT ultrasound
- i. Early Risk Assessment- First Trimester Screening
- ii. Non-Invasive Prenatal Testing (NIPT)- (see handout)
 - 1. If you are interested in getting NIPT, make sure to check your insurance coverage first
 - a. CPT code 81420

4. Optional Genetic Carrier Screening

- a. See handout with detailed information
- b. You have the option to have these tests done today or you can decline and check with your insurance for coverage and get testing done at a later date- a consent will be signed either way

5. Harmful Agents

- a. Tobacco/Marijuana or CBD products including edible use is not recommended in pregnancy
 - i. Complications can include SIDS, low birth weight, neonatal death
- b. No illicit drug use in pregnancy
 - i. Including cocaine, heroin, suboxone or subutex, and any other non prescribed medication obtained illegally
- c. Zero Alcohol in pregnancy
- d. Drug testing is done with this visit. They are also done throughout the entire pregnancy if there is a history of or current drug abuse if a patient is on any narcotics even if prescribed (including subutex/methadone/klonopin), or for any other reason the provider sees fit.

6. Domestic Violence

- a. 24-hour toll-free number 800-799-7233
- b. Feel free to discuss with your provider any changes in mood or behavior at any point in the pregnancy

7. Vaccinations

- a. We recommend you get the following vaccines during pregnancy
 - i. Flu vaccine- during the flu season
 - ii. Tdap vaccine- best to get between 27-36 weeks of pregnancy
- b. Please see your PCP to receive both these vaccines

Frequency of Office Visits:

After the intake, we generally see patients every 4 weeks in the 1st & 2nd trimesters and then every 2 weeks until the last month at which point we see you weekly. Visits: 12,16,20,24,28,30,32,34,36,37,38,39,40
